Once designs are submitted, Lockwood & Zahrbock Kool Law Office will choose the top five and then will share the designs on our website and Facebook page for the community to vote on their favorite and one winner will be chosen!

- Must cover the outside wall (12’ X 100’ area) on the southside of LZK overlooking the 10th street viaduct entering downtown Sioux Falls.

MURAL CONTEST DETAILS

- Design can be in color and/or black and white (feel free to submit both, if you want!) Submission does not have to be the final design- a concept sketch is acceptable.
- All design styles will be considered.
- Must be “PG”- may not include nudity, foul language, or drug, tobacco/vaping or alcohol references.
- Design will be painted directly onto the wall and is the responsibility of the artist and/or designer to effectuate the completion of the project.
- The building owner will retain rights to remove the art at any time. Our intention is to keep it at the very least for one year, if not permanently.
- Building owner and all parties involved in the promotion retain rights to use art painted for promotional material, both printed and digital.
- Should the building change ownership, the new owner will have right to remove as they see fit.
- Long term repairs of the mural fall on the building owner.
- Owner will provide a clean, freshly painted wall and pay for the supplies to create the mural.
- The artist/designer is responsible for any potential tax obligations as the recipient of award from the mural contest and thus responsible for discussing such with their own accountant.
